No. 189-88 8 establish the position of Chief Financial Officer with 9 prescribed duties and responsibilities "for receiving, 10safekeeping and disbursement of the Nation's funds. 11 Also responsible for protecting the Nation's interest in 12all financial matters." 13

BE IT FURTHER RESOLVED that, until further order of this Council, 19 any funds of the Tohono O'odham Nation deposited in such 20 accounts be subject to withdrawal or charge at any time 21 upon checks, notes, drafts, bills of exchange, 22acceptances, undertakings or other instruments or orders $\mathbf{23}$ for the payment when made, signed, drawn, accepted, or 24 endorsed on behalf of the Tohono O'odham Nation by any 25two of the following officers, namely the Chief 26Financial Officer, the Chairman and Vice Chairman of the 27Nation. 28
