

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Head Start Program)

RES. NO. 197-88

1 WHEREAS, the Tohono O'Odham Nation has recognized the importance
2 of Head Start Education and stimulation; and

3 WHEREAS, the Tohono O'Odham Nation has operated a Head Start
4 Program to provide and serve educational and pre-school
5 learning experiences for children between the ages of 3-
6 5 years; and

7 WHEREAS, the Department of Health & Human Services,
8 Administration for Children, Youth and Families, has
9 provided funding for the operation of the Head Start
10 Program; and

11 WHEREAS, the Administration for Children, Youth & Families will
12 provide funds for the continued operation of the Head
13 Start program to eligible and qualifying applicants; and

14 WHEREAS, the Head Start program has prepared a proposal for FY
15 '89 program operations to be submitted to the Department
16 of Health & Human Services; and

17 WHEREAS, the Tohono O'Odham Council has reviewed and approved the
18 Head Start grant.

19 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that
20 it does authorize and request the Department of Health &
21 Human Services to contract with the Tohono O'Odham
22 Nation for the provision of services titled: Head Start
23 Program.

24 BE IT FURTHER RESOLVED that the approved budget is subject to
25 change once a decision is made on the Cost of Living
26 Allowance (COLA) rate.

27 BE IT FURTHER RESOLVED that the duration of this grant will be
28 from November 01, 1988 through October 31, 1989.

29 BE IT FURTHER RESOLVED that the Tohono O'Odham Nation will not
30 fund or operate a program from which grants are
31 requested herewith which have not been negotiated and
32 executed by the Department of Health & Human Services
prior to the start of the funding year.

1 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
2 that the Chairman, Vice-Chairman and Treasurer of the
3 Tohono O'Odham Nation are hereby authorized to negotiate
4 and execute this grant and any amendments thereto for
5 the duration of the grant, provided however, that any
6 amendments affecting the funding or funding levels of
7 this grant shall be submitted for further prior
8 approval by this Council.

9 The foregoing resolution was passed by the Tohono O'odham Council
10 on the 1st. day of August, 1988 at a meeting at which a quorum
11 was present with a vote of 1,640.0 for; -0- against; -0- not
12 voting; and 02 absent, pursuant to the powers vested in the
13 Council by Section 1 (f) of Article VI of the Constitution of
14 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
15 on January 18, 1986, and approved by the Acting Deputy Assistant
16 Secretary - Indian Affairs (Operations) on March 6, 1986,
17 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
18 984).
