(Authority for the Tohono O'Odham Human Service  
Department to apply for commodities for the Group Homes)

1 WHEREAS, the Tohono O'Odham Human Service Department is presently  
2 providing meals for residents of the Adult Care Group  
3 Home, Developmentally Disabled Group Home, Adolescent  
4 Boys Home, and the Children's Home; and

5 WHEREAS, the Tohono O'Odham Human Service Department does desire  
6 to provide nutritionally adequate meals for the  
7 residents of the Group Homes; and


8 WHEREAS, the Arizona Department of Education has programs  
9 available which would aid in providing nutritionally  
10 adequate meals for the residents of the Group Homes; and

11 WHEREAS, it would be beneficial for the Tohono O'Odham Human  
12 Service Department to apply for commodities through the  
13 Charitable Institution Program with the Arizona  
14 Department of Education.


15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
16 Council that it does authorize and request the Tohono  
17 O'Odham Human Service Department to apply for  
18 commodities through the Charitable Institution Program  
19 with the Arizona Department of Education.

22 on the 2nd day of August, 1988 at a meeting at which a quorum  
23 was present with a vote of 1,577.0 for; -0- against; 63.0 not  
24 voting; and 05 absent, pursuant to the powers vested in the  
25 Council by Section 1 (f) of Article VI of the Constitution of  
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
