Services Department not to participate in the Bureauwide

Quality Control effort.

BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
Council recommends that all Quality Control efforts be
conducted by Area Office personnel based on the 25 CFR
Part 20 and the Tohono O'Odham Social Service Manual.
