

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Opposition to the Bureauwide Quality Control Effort)

RES. NO. 202-88

1 WHEREAS, the Bureau of Indian Affairs, Central Office has issued
2 a Memorandum directing Tribal Social Service Program to
3 submit selected client case records to the area office
4 for the purpose of a Bureauwide Quality Control Review
5 effort; and

6 WHEREAS, the Tohono O'Odham Nation supports the concept of
7 Quality Control Reviews when said reviews are based
8 solely on the 25 CFR Part 20; and

9 WHEREAS, the Tohono O'Odham Nation further supports Quality
10 Control Reviews conducted by Area Office; and


11 WHEREAS, the Tohono O'Odham Nation has reviewed the position
12 statement on Bureauwide Quality Control and supports the
13 positions.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
15 Legislative Council directs the Tohono O'Odham Human
16 Services Department not to participate in the Bureauwide
17 Quality Control effort.

18 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
19 Council recommends that all Quality Control efforts be
20 conducted by Area Office personnel based on the 25 CFR
21 Part 20 and the Tohono O'Odham Social Service Manual.

22 The foregoing resolution was passed by the Tohono O'odham Council
23 on the 2nd. day of August, 1988 at a meeting at which a quorum
24 was present with a vote of 1,336.0 for; -0- against; 304.0
25 not voting; and 01 absent, pursuant to the powers vested in the
26 Council by Section 1(j) of Article VI of the Constitution of
27 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
28 on January 18, 1986, and approved by the Acting Deputy Assistant
29 Secretary - Indian Affairs (Operations) on March 6, 1986,
30 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
31 984).
