- WHEREAS, the Tohono O'Odham Legislative Council is desirous to protect and ensure the well-being of these children and their families; and
- WHEREAS, funding for services to handicapped children 0-2 years of age is available through Public Law 99-457 effective October 1, 1988; and
- WHEREAS, the Bureau of Indian Affairs is the contract agency designated to receive P. L. 99-457 funds on the behalf of Indian Tribes.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Health Department enter into a Cooperative Agreement with the Bureau of Indian Affairs, Arizona Department of Economic Security, and the Indian Health Service in order for the Bureau of Indian Affairs to procure funds in order to provide services to handicapped children 0-2 and their families.

The foregoing resolution was passed by the Tohono O'odham Council on the 3rd. day of August , 1988 at a meeting at which a quorum was present with a vote of 1,514.0 for; -0- against; -0- not voting; and 126.0 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
