

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the San Xavier Agricultural Development Plan)

RES. NO. 206-88

1 WHEREAS, the Tohono O'Odham Legislative Council convened in a  
2 meeting on August 4, 1988 to hear comments on the draft  
3 San Xavier Development Plan and to consider approval of  
4 the preferred plan (9B) in Chapter 6 of the Development  
5 Plan; and


6 WHEREAS, the Legislative Council recognizes the need to expedite  
7 activities to initiate design of the preferred plan in  
8 order to complete construction by October 12, 1992; and

9 WHEREAS, the Legislative Water Resource Committee has reviewed  
10 and approved the Development Plan and has submitted  
11 comments for the record.


12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation  
13 approves the San Xavier Development Plan prepared by  
14 Franzoy Corey Engineers and Architects and reviewed in  
15 accordance with comments provided by the Nation and said  
16 plan, is hereby accepted as the final project plan  
17 report for submittal to the United States Bureau of  
18 Reclamation as a basis to initiate project pre-design  
19 activities.

20 The foregoing resolution was passed by the Tohono O'odham Council  
21 on the 4th day of August, 1988 at a meeting at which a quorum  
22 was present with a vote of 878.5 for; 63.0 against; 698.5 not  
23 voting; and 02 absent, pursuant to the powers vested in the  
24 Council by Section 1(i)(2) & (j) of Article VI of the  
25 Constitution of the Tohono O'odham Nation, adopted by the Tohono  
26 O'odham Nation on January 18, 1986, and approved by the Acting  
27 Deputy Assistant Secretary - Indian Affairs (Operations) on March  
28 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
29 Stat. 984).


