

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Notice of Intent to Apply for Small Reclamation Loan
for the Development of Lands within the
San Xavier District)

RES. NO. 207-88

1 WHEREAS, to expedite the subjugation of tribal lands within the
2 San Xavier District for the purpose of utilizing Central
3 Arizona Project water to be delivered in 1992 as
4 mandated by Title III of Public Law 97-293 (27,000 acre
5 feet), and for the purpose of utilizing the exchange
6 water as mandated by said Act (23,000 acre feet), it
7 might be necessary to file an application for Small
8 Reclamation interest free loan under Public Law 84-984;
9 and

10 WHEREAS, filing a notice of intent to apply for a Small
11 Reclamation Loan does not create an obligation or
12 liability on the Nation or require the Nation to acquire
13 a loan; and

14 WHEREAS, it would be in the best interest of the Tohono O'Odham
15 Nation if the Nation's Chairman immediately file a
16 Notice of Intent to Apply for a Small Reclamation Loan
17 under P. L. 84-984, in order to establish a priority of
18 the Nation's right to an interest-free loan in the event
19 the Nation finds it necessary to acquire a loan for the
20 purposes set forth hereinabove.

21 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does
22 hereby authorize the Chairman to file immediately a
23 formal notice of the nation's intent to apply for a
24 Small Reclamation Loan under P. L. 94-984 for the
25 subjugation and development of tribal lands located
26 within the San Xavier District so that the Nation may
27 utilize the water to be delivered in 1992 as mandated by
28 Title III of Public Law 97-293.

30 The foregoing resolution was passed by the Tohono O'odham Council
31 on the 4th day of August, 1988 at a meeting at which a quorum
32 was present with a vote of 1,524.5 for; 63.0 against; 52.5
not voting; and 02 absent, pursuant to the powers vested in the
Council by Section 1(i)(2) & (j) of Article VI of the
Constitution of the Tohono O'odham Nation, adopted by the Tohono
