23		hereby authorize the Chairman to file immediately a
24		formal notice of the nation's intent to apply for a
25		Small Reclamation Loan under P. L. 94-984 for the
26		subjugation and development of tribal lands located within the San Xavier District so that the Nation may
27		utilize the water to be delivered in 1992 as mandated by
28		Title III of Public Law 97-293.
