

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the recommendation to terminate
the O'Odham In Mexico Director)

RES. NO. 208-88

1 WHEREAS, the Domestic Affairs Committee met with the O'Odham In
2 Mexico Board to hear their concerns regarding the
3 difficulties in the operation of the O'Odham In Mexico
4 Office and the Director; and

5 WHEREAS, the presentation made by the O'Odham In Mexico Board to
6 the Domestic Affairs Committee resulted in the Committee
7 supporting the recommendation of O'Odham In Mexico Board
8 to the Nations' Chairman to terminate the O'Odham In
9 Mexico Director; and

10 WHEREAS, the Domestic Affairs Committee by Memorandum dated July
11 28, 1988, made it known to the Nation's Chairman that
12 they are in support of the O'Odham In Mexico Board
13 recommendation to terminate the O'Odham In Mexico
14 Director; and

15 WHEREAS, the Domestic Affairs Committee in the same Memorandum
16 notified the Nation's Chairman to respond by August 3,
17 1988 on what action he plans to take regarding their
18 recommendation; and

19 WHEREAS, the Domestic Affairs Committee further advised the
20 Chairman of the Nation that if no response was received
21 by August 3, 1988 they would proceed with their plan to
22 place the issue on the August Legislative Session
23 wherein they would ask for their support.

24 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
25 Council that it hereby supports the recommendation of
26 the Domestic Affairs Committee to terminate the O'Odham
27 In Mexico Director, including the actions documented in
28 the attached minutes.

30 The foregoing resolution was passed by the Tohono O'odham Council
31 on the 5th. day of August, 1988 at a meeting at which a quorum
32 was present with a vote of 1,369.0 for; -0- against; 271.0
not voting; and 01 absent, pursuant to the powers vested in the
Council by Section 1 (b) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
