5 officers of the Tohono O'Odham Nation reduce this final  
6 determination in writing regarding each of the foregoing  
7 applications for enrollment in accordance with Section 3  
8 (c) of Article III of the Enrollment Ordinance; give  
9 notice of this Council's determination in accordance  
10 with Section 4 of Article III of the Enrollment  
11 Ordinance; and place the names of each applicant upon  
12 the membership roll of the Tohono O'Odham Nation in  
13 accordance with Article V of the Enrollment Ordinance.

14 The foregoing Resolution was passed by the Tohono O'Odham Council  
15 on the 6th day of September, 1988 at a meeting at which a quorum  
16 was present with a vote of 1,519.0 for; -0- against; 121.0 not  
17 voting; and 01 absent, pursuant to the powers vested in the  
18 Council by Section 1 of Article II and of Section 1 (h) of  
19 Article VI of the Constitution of the Tohono O'Odham Nation,  
20 adopted by the Tohono O'Odham Nation on January 18, 1986 and  
21 approved by the Acting Deputy Assistant Secretary - Indian  
22 Affairs (Operations) on March 6, 1986 pursuant to Section 16 of  
23 the Act of June 18, 1934 (48 Stat. 984).
