

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Hickiwan District Budget FY '89)

1 WHEREAS, the District Council of the Hickiwan District did on  
2 August 10, 1988 by Resolution No. 8-88, approve their  
3 District Budget in the amount of One Hundred Fourteen  
4 Thousand, Two Hundred Eighty-Four Dollars (\$114,284.00);  
5 and

6 WHEREAS, the Hickiwan District Council has sufficient funds in  
7 their District account on deposit with the Tohono  
8 O'odham Accounting Department to cover their proposed  
9 budget; and

10 WHEREAS, the Tohono O'odham Legislative Council has reviewed the  
11 Hickiwan District Budget which is attached and finds it  
12 in order.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
14 Council that it hereby approves the Hickiwan District  
15 Budget as presented, in the amount of One Hundred  
16 Fourteen Thousand, Two Hundred Eighty-Four Dollars  
17 (\$114,284.00) and authorizes expenditures in accordance  
18 therewith.


19 The foregoing resolution was passed by the Tohono O'odham Council

24 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
25 on January 18, 1986, and approved by the Acting Deputy Assistant  
26 Secretary - Indian Affairs (Operations) on March 6, 1986,  
27 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
28 984).
