1 WHEREAS, the Chukut Kuk District Council has considered and
2 reviewed its proposed activities for FY '89 and has
3 prepared a budget to cover anticipated costs and
4 expenses; and

5 WHEREAS, the Chukut Kuk District Council did adopt the proposed
6 budget for October 01, 1988 and end on September 30,
7 1989; and

8 WHEREAS, the Tohono O'odham Legislative Council has reviewed the
9 proposed budget and approves of same.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
11 Council that it hereby approves the Chukut Kuk District
12 Council's Budget to be expended in accordance with the
13 attached budget.

14 The foregoing resolution was passed by the Tohono O'odham Council
15 on the 6th. day of September, 1988 at a meeting at which a
16 quorum was present with a vote of 1,577.0 for; -0- against;
17 63.0 not voting; and 01 absent, pursuant to the powers vested
18 in the Council by Section 1 (d) of Article VI of the
19 Constitution of the Tohono O'odham Nation, adopted by the Tohono
20 O'odham Nation on January 18, 1986, and approved by the Acting
21 Deputy Assistant Secretary - Indian Affairs (Operations) on March
22 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
23 Stat. 984).
