

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Gu Achi District FY 88-89 Budget)

1 WHEREAS, the Gu Achi District Council has considered and reviewed
2 its District Budget for FY 88-89 and has prepared a
3 proposed budget to cover anticipated costs and expenses
4 for FY 88-89; and

5 WHEREAS, the Gu Achi District Council did adopt and approve the
6 proposed budget for FY 1989 in the amount of
7 \$191,055.12; and

8 WHEREAS, the Tohono O'odham Legislative Council has reviewed the
9 proposed budget and approves.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
11 Council that it hereby approves the Gu Achi District
12 Council's budget to be expended in accordance with the
13 attached budgets.

14 The foregoing resolution was passed by the Tohono O'odham Council
15 on the 6th day of September, 1988 at a meeting at which a
16 quorum was present with a vote of 1,640.0 for; -0- against; -0-
17 not voting; and 01 absent, pursuant to the powers vested in the
18 Council by Section 1 (d)(3) of Article VI of the Constitution
19 of the Tohono O'odham Nation, adopted by the Tohono O'odham
20 Nation on January 18, 1986, and approved by the Acting Deputy
21 Assistant Secretary - Indian Affairs (Operations) on March 6,
22 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
23 Stat. 984).
