7 Council that it hereby approves the San Xavier District
8 FY '89 budget in the amount of \$255,689.26, to be
9 expended in accordance with the attached budget.

14 the Council by Section 1 (d) of Article VI of the Constitution
15 of the Tohono O'odham Nation, adopted by the Tohono O'odham
16 Nation on January 18, 1986, and approved by the Acting Deputy
17 Assistant Secretary - Indian Affairs (Operations) on March 6,
18 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
19 Stat. 984).
