

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Opposing the Indian Regulatory Act)

RES. NO. 224-A-88

1 WHEREAS, there is now pending before Congress Senate Bill S. 555  
2 entitled the Indian Gaming Regulatory Act drafted for  
3 the purpose of regulating gaming on Indian lands; and  
4 WHEREAS, this Legislative Council has reviewed and discussed the  
5 provision of S. 555 and believe that if this bill is  
6 enacted into law it will be detrimental to the economic  
7 development and self sufficiency of the Tohono O'odham  
8 Nation and will destroy our Tribal right of self-  
9 government by unilaterally imposing upon the Nation  
10 State rule and authority; and  
11 WHEREAS, it is the belief of this Council that it is mandatory  
12 that it go on record as opposing S.555 as a piece of bad  
13 legislation that if enacted into law would be damaging  
14 to Indian self-government and Indian rights.  
15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham  
16 Legislative Council does hereby oppose the enactment of  
17 S.555 into law and authorizes the notification of our  
18 Congressional Delegation in Washington D.C., the U.S.  
19 House Interior Committee and the U.S. Senate Select  
20 Committee on Indian Affair and the Judiciary Committee  
21 of our opposition to S.555 and request that everything  
22 be done that is necessary to present this bill from  
23 being enacted into law.

25 The foregoing Resolution was passed by the Tohono O'odham Council  
26 on the 6th day of September, 1988 at a meeting at which a  
27 quorum was present with a vote of 1,640.0 for; -0- against; -0-  
28 not voting; and 02 absent, pursuant to the powers vested in the  
29 Council by Section 1 (j) of Article VI of the Constitution of  
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
