WHEREAS, the Tohono O'Odham Nation is presently operating the Management of Health Program under FY 1988, P. L. 93-638 contract with the Public Health, Indian Health Services; and

WHEREAS, any amendments affecting the funding level of the contract shall be submitted for review and approval by this Tohono O'Odham Legislative Council; and


WHEREAS, an amendment has been submitted by the Tohono O'Odham Management of Health for review and approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the amendment to the Tohono O'Odham Management of Health contract.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Chairman, Vice Chairman and Treasurer of the Tohono O'Odham Nation are hereby authorized to negotiate and execute this contract and any amendments thereto for the duration of this contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by the Council.


The foregoing resolution was passed by the Tohono O'Odham Council on the 1st. day of February, 1988, at a meeting at which a quorum was present with a vote of 1,317.5 for; 179.5 against; 143.0 not voting; and 01 absent; pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


