

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Weatherization Assistance)

RES. NO. 228-88

1 WHEREAS, Block Grant applications have been made available for
2 tribal grants for FY 1989 through the State of Arizona,
3 Department of Commerce for Weatherization Programs; and

4 WHEREAS, the Weatherization Assistance is available to the Tohono
5 O'Odham Nation and the Tohono O'Odham Nation does meet
6 the eligibility requirements; and

7 WHEREAS, it is in the best interest of the Tohono O'Odham Nation
8 to apply for FY 1989 Weatherization Assistance; and

9 WHEREAS, the Tohono O'Odham Nation believes that it will satisfy
10 the eligibility criteria set forth in the funding and
11 reporting regulations.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
13 Legislative Council does hereby authorize the officials
14 of the Tohono O'Odham Nation to submit a request for
15 Weatherization Assistance funding from the State of
16 Arizona, Department of Commerce.

17 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or
18 Treasurer of the Tohono O'Odham Nation are hereby
19 authorized to negotiate and execute this grant and any
20 amendments affecting the funding or funding levels of
21 this contract shall be submitted for further prior
22 approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Council
24 on the 7th. day of September, 1988 at a meeting at which a
25 quorum was present with a vote of 1,577.0 for; -0- against;
26 63.0 not voting; and 02 absent, pursuant to the powers vested
27 in the Council by Section 1 (f) of Article VI of the
28 Constitution of the Tohono O'odham Nation, adopted by the Tohono
29 O'odham Nation on January 18, 1986, and approved by the Acting
30 Deputy Assistant Secretary - Indian Affairs (Operations) on March
31 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
32 Stat. 984).
