1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Johnson O'Malley Educational Services Program under a P.
3 L. 93-638 contract with the Bureau of Indian Affairs;
4 and

5 WHEREAS, any amendments affecting the funding or funding levels
6 of the contract shall be submitted for review and
7 approval by the Tohono O'Odham Legislative Council; and


8 WHEREAS, an amendment has been submitted by the Tohono O'Odham
9 Nation's Johnson O'Malley Education Services Program for
10 review and approval.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
12 Legislative Council does approve the amendment to the
13 Johnson O'Malley Educational Services Contract.


14 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or
15 Treasurer of the Tohono O'Odham Nation are hereby
16 authorized to negotiate and execute this contract and
17 any amendments affecting the funding or funding levels
18 of this contract shall be submitted for further prior
19 approval by this Council.

21 The foregoing Resolution was passed by the Tohono O'odham Council
22 on the 7th day of September, 1988 at a meeting at which a
23 quorum was present with a vote of 1,640.0 for; -0- against; -0-
24 not voting; and 01 absent, pursuant to the powers vested in the
25 Council by Section 1 (f) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
