

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Rodeo & Fair Committee and Miss Tohono
O'odham Committee Advance Costs)

RES. NO. 234-88

1 WHEREAS, the 51st annual Rodeo and Fair was established as an
2 event for the Nation as a whole to have a celebration
3 for its members and to promote good public relations
4 with nonmembers; and

5 WHEREAS, the events include the rodeo, fair, art show, pow-wow,
6 exhibits, fun run/walk, parade, traditional dances, band
7 jams, as well as other sporting activities, etc.; and

8 WHEREAS, the Miss Tohono O'odham Nation's Committee is proceeding
9 in planning the 26th Annual Miss Tohono O'odham Nation's
10 Pageant in conjunction with the Nation's Rodeo and Fair;
11 and

12 WHEREAS, both the Rodeo & Fair Committee and the Miss Tohono
13 O'odham Committee are in need of advance funds to take
14 care of preliminary costs associated with both events;
15 and

16 WHEREAS, such costs will be applied to their FY '89 budgets.

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
18 Legislative Council does hereby authorize the
19 expenditure of funds for the Rodeo and Fair in the
20 amount of \$2,348.00 and funds for the Miss Tohono
21 O'odham Pageant in the amount of \$3,295.00, effective
22 immediately upon final approval by the Nation.

23 AND BE IT FURTHER RESOLVED THAT such amounts will be reflected
24 in the FY 89 budgets as a reduction of \$ 2,348.00 for
25 the Rodeo and Fair and a reduction of 3,295.00 for the
26 Miss Tohono O'odham Committee.

27 The foregoing resolution was passed by the Tohono O'odham Council
28 on the 8th. day of September, 1988 at a meeting at which a
29 quorum was present with a vote of 1,095.0 for; 105.5 against;
30 439.5 not voting; and 01 absent, pursuant to the powers vested
31 in the Council by Section 1 (d)(2) of Article VI of the
32 Constitution of the Tohono O'odham Nation, adopted by the Tohono
Deputy Assistant Secretary - Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
