

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adoption of Skill Center Request for an
Extension of BIA Contract)

RES. NO. 235-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Skill Center Program under a P. L. 93-638 contract with
3 the Bureau of Indian Affairs; and

4 WHEREAS, such Tribal operations have been successful and
5 beneficial to the Tohono O'Odham Nation; and

6 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
7 funding status of the Skill Center and does desire to
8 extend the existing contract.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
10 Council that it hereby authorizes and requests the
11 Bureau of Indian Affairs to approve the attached budget
12 modification contracting for FY '88 and FY '89 funds and
13 to extend the existing Skill Center Contract No.
14 H50C14206317 through September 30, 1989.

15 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or
16 Treasurer of the Tohono O'Odham Nation are hereby
17 authorized to negotiate and execute this contract and
18 any amendments thereto for the duration of the contract,
19 provided however, that any amendments affecting the
20 funding or funding levels of this contract shall be
21 submitted for further prior approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Council
24 on the 8th day of September, 1988 at a meeting at which a
25 quorum was present with a vote of 1,102.5 for; 537.5 against;
26 -0- not voting; and -0- absent, pursuant to the powers vested
27 in the Council by Section 1 (f) of Article VI of the
28 Constitution of the Tohono O'odham Nation, adopted by the Tohono
29 O'odham Nation on January 18, 1986, and approved by the Acting
30 Deputy Assistant Secretary - Indian Affairs (Operations) on March
31 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
32 Stat. 984).
