NOW, THEREFORE, IT RESOLVED BE that the Tohono O'Odham Legislative Council does approve \$18,000.00 to be taken out of the \$60,000.00 projected as monies which will not be part of the General Counsel's Contract.

BE IT FURTHER RESOLVED that \$15,000.00 is to be used for legal fees for an attorney and other necessary expenses to help the individuals out of Mexico plus \$3,000.00 for the expenses of a representative from each of the three men's family who will follow up on this matter.

BE IT FURTHER RESOLVED that the O'Odham In Mexico Office and the Domestic Affairs Committee are delegated the duty to follow up on this matter.

The foregoing Resolution was passed by the Tohono O'odham Council on the 9th. day of September , 1988 at a meeting at which a quorum was present with a vote of 1,210.0 for; -0- against; 430.0 not voting; and 08 absent, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
