

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Schuk Toak Pre-Design Contract No. 8-CS-30-00380
Budget Amendment #2)

DEFEATED

2 WHEREAS, the Tohono O'odham Nation is presently operating the
3 Schuk Toak Pre-Design Program under a P.L. 93-638
4 contract with the Bureau of Reclamation; and

5 WHEREAS, any amendments affecting the funding or funding levels
6 of the contract shall be submitted for review and
7 approval by the Tohono O'odham Legislative Council; and

8 WHEREAS, an amendment has been submitted by the Tohono O'odham
9 Nation's Central Arizona Water Project for review and
10 approval.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
12 Legislative Council does hereby approve the amendment to
13 the Schuk Toak Pre-Design Contract.

14 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or
15 Treasurer of the Tohono O'odham Nation are hereby
16 authorized to negotiate and execute this contract and
17 any amendments thereto for the duration of the contract,
18 provided however, that any amendments affecting the
19 funding or funding levels of this contract shall be
20 submitted for further prior approval by this Council.

21 The foregoing resolution was DEFEATED by the Tohono O'odham
22 Council on the 12th day of September, 1988 at a meeting at which
23 a quorum was present with a vote of 456.5 for; 939.5 against;
24 244.0 not voting; and 05 absent, pursuant to the powers vested in
25 the Council by Section 1 (f) of Article VI of the Constitution
26 of the Tohono O'odham Nation, adopted by the Tohono O'odham
27 Nation on January 18, 1986, and approved by the Acting Deputy
28 Assistant Secretary - Indian Affairs (Operations) on March 6,
29 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
30 Stat. 984).
