2 Credit and Finance Program under a P. L. 93-638 contract
3 with the Bureau of Indian Affairs; and

4 WHEREAS, any amendments affecting the funding or funding levels
5 of the contract shall be submitted for review and
6 approval by the Tohono O'Odham Legislative Council; and


7 WHEREAS, an amendment has been submitted by the Tohono O'Odham
8 Nation's Credit and Finance Program for review and
9 approval.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
11 Legislative Council does approve the amendment to the
12 Credit and Finance Services Contract.


13 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or
14 Treasurer of the Tohono O'Odham Nation are hereby
15 authorized to negotiate and execute this contract and
16 any amendments thereto for the duration of the contract,
17 provided however, that any amendments affecting the
18 funding or funding levels of this contract shall be
19 submitted for further prior approval by this Council.

20 The foregoing Resolution was passed by the Tohono O'odham Council
21 on the 12th day of September, 1988 at a meeting at which a
22 quorum was present with a vote of 1,156.0 for; 63.0 against;
23 421.0 not voting; and 03 absent, pursuant to the powers
24 vested in the Council by Section 1 (f) of Article VI of the
25 Constitution of the Tohono O'odham Nation, adopted by the Tohono
26 O'odham Nation on January 18, 1986, and approved by the Acting
27 Deputy Assistant Secretary - Indian Affairs (Operations) on March
28 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
29 Stat. 984).
