(Approving Water Resources Committee to attend a meeting with  
the Bureau of Reclamation in Boulder, Nevada)

RES. NO. 25-88

1 WHEREAS, the Bureau of Reclamation will be holding an orientation  
2 in Boulder, Nevada on February 12, 1988; and

3 WHEREAS, such a meeting does give the Water Resources Committee  
4 of the Legislative Branch an opportunity to meet the  
5 officials and gain insight and information to be used  
6 when following up on the development of the projects  
7 stemming out of the Tohono O'Odham Nation's Water  
8 Settlement Act; and

9 WHEREAS, the trust funds under the Act has been identified as  
10 the source to finance this trip.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
12 Legislative Council does hereby approve the Water  
13 Resources Committee to go to Boulder, Nevada to meet  
14 with the Bureau of Reclamation on February 12, 1988.

15 BE IT FURTHER RESOLVED that the expense will be paid out of the  
16 Water Trust Funds and the Water Resources Committee  
17 shall give a report to the Tohono O'Odham Legislative  
18 Council upon their return.



24 in the Council by Section 1 (j)(d)(2) of Article VI of the  
Constitution of the Tohono O'Odham Nation on January 18, 1986,  
and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).
