LEGIS. ORDER NO. 258-88

1 WHEREAS, on Wednesday, September 21, 1988 the Legislative Budget  
2 and Finance Committee presented a budget for the Nation  
3 for FY '89 with Committee recommendations and projected  
4 revenues for FY '89; and

5 WHEREAS, on Thursday, September 22, 1988 the Legislative Council  
6 Council continued to discuss the recommended Tohono  
7 O'odham Nation Budget for FY '89; and

8 WHEREAS, on Friday, September 23, 1988 the Legislative Council  
9 reviewed budget appeals from the following departments/

20 Council that it hereby tables the Tohono O'odham Nation  
21 Budget for FY '89.

22 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative  
23 Council reconvene on Monday, September 26, 1988 to  
24 address the Tohono O'odham Nation budget for FY '89.


25 The foregoing ORDER was passed by the Tohono O'odham Council on

29 Council by Section 1(a) of Article VI of the Constitution of  
30 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
31 on January 18, 1986, and approved by the Acting Deputy Assistant  
32 Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
