

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(General Counsel Contract)

RES. NO. 259-88

1 WHEREAS, the Tohono O'Odham Nation has retained the law firm of  
2 Strickland and Altaffer, P.C. under a General Counsel  
3 Contract dated as of the 24th day of September, 1987,  
4 (Symbol H50C1420-Contract No. 7337); and

5 WHEREAS, said General Counsel Contract expires on the 24th day of  
6 September, 1988, and the law firm of Strickland and  
7 Altaffer, P.C. has performed its duties under said  
8 contract proficiently and competently; and

9 WHEREAS, it is the desire of the Nation to retain the law firm of  
10 Strickland and Altaffer, P.C. as general counsel for an  
11 additional period of one (1) year.

12 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that  
13 the law firm of Strickland and Altaffer, P.C. be  
14 employed by the Tohono O'Odham Nation under and pursuant  
15 to the terms of the attached General Counsel Contract,  
16 and any amendments or extension thereof, and the  
17 Chairman of the Tohono O'Odham Nation is hereby  
18 authorized and directed to execute said Contract for and  
19 on behalf of the Nation.

20 The foregoing Resolution was passed by the Tohono O'odham Council  
21 on the 23th. day of September, 1988 at a meeting at which a  
22 quorum was present with a vote of 1,152.5 for; 429.0 against;  
23 58.5 not voting; and 03 absent, pursuant to the powers vested  
24 in the Council by Section 2(a) of Article VI of the Constitution  
25 of the Tohono O'odham Nation, adopted by the Tohono O'odham  
26 Nation on January 18, 1986, and approved by the Acting Deputy  
27 Assistant Secretary - Indian Affairs (Operations) on March 6,  
28 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
29 Stat. 984).
