including Projected Revenues and Committee Recommendations)

1 WHEREAS, the Budget & Finance Committee did review and made a
2 forecast of projected revenues; and

3 WHEREAS, the Budget & Finance Committee did also make
4 recommendations regarding the FY '89 Budgets for the
5 Tohono O'Odham Nation; and

6 WHEREAS, the final recommendations to the Tohono O'Odham
7 Legislative Council were presented and are attached.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
9 Legislative Council does hereby adopt the attached
10 Tohono O'Odham Nation's Budgets in the amount of
11 \$4,304,500.00 and projected revenues at \$4,304,500.00 .

13 The foregoing Resolution was passed by the Tohono O'odham Council
14 on the 26th day of September, 1988 at a meeting at which a
15 quorum was present with a vote of 987.5 for; 526.5 against;
16 126.0 not voting; and 06 absent, pursuant to the powers vested
17 in the Council by Section 1 (d)(2)(3) of Article VI of the
18 Constitution of the Tohono O'odham Nation, adopted by the Tohono
19 O'odham Nation on January 18, 1986, and approved by the Acting
20 Deputy Assistant Secretary - Indian Affairs (Operations) on March
21 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
22 Stat. 984).




