

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Withdrawal of Economic Development Funds for Sif-Oidak District)

RES. NO. 26-88

1 WHEREAS, the Tohono O'odham Legislative Council did allocate
2 \$100,000.00 for each of the eleven districts; and

3 WHEREAS, the said amount was made available to promote Economic
4 Development within the respective districts; and

5 WHEREAS, the Sif-Oidak District Council did meet on January 09,
6 1988 and decided to withdraw the said amount from the
7 IIM Account.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legis-
9 lative Council does hereby approve the withdrawal of One
10 Hundred Thousand Dollars (\$100,000.00) to be deposited
11 in private institutions, namely, Mera Bank and Pima
12 Savings.

13 BE IT FURTHER RESOLVED that the Sif Oidak District shall present
14 their proposal to the Budget & Finance and Commerce
15 Committees for review and to the Tohono O'odham
16 Legislative Council for approval.

17 The foregoing resolution was passed by the Tohono O'odham
18 Council on the 2nd day of February, 1988, at a meeting at which
19 a quorum was present with a vote of 1,640.0 for; -0- against;
20 -0- not voting; and -0- absent; pursuant to the powers vested in
21 the Council by Section 1 (d) of Article VI of the Constitution of
the Tohono O'odham Nation on January 18, 1986, and approved by
the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).




