H5OC14208055)

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 Law Enforcement Program under a P.L. 93-638 contract
3 with the Bureau of Indian Affairs; and

4 WHEREAS, funding for FY '88 pay cost increase has become
5 available; and

6 WHEREAS, any amendments affecting the funding or funding levels
7 of the contract shall be submitted for review and
8 approval by the Tohono O'odham Legislative Council; and


9 WHEREAS, an amendment has been submitted by the Tohono O'odham
10 Nation's Law Enforcement Program for review and
11 approval.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
13 Legislative Council does hereby approve the amendment
14 of the Law Enforcement Contract.

15 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or
16 Treasurer of the Tohono O'odham Nation are hereby
17 authorized to negotiate and execute this contract and
18 any amendments thereto for the duration of the contract,
19 provided however, that any amendments affecting the
20 funding or funding levels of this contract shall be
21 submitted for further prior approval by this Council.

22 The foregoing resolution was passed by the Tohono O'odham Council
23 on the 26th day of September, 1988 at a meeting at which a
24 quorum was present with a vote of 1,640.0 for; -0- against; -0-
25 not voting; and 06 absent, pursuant to the powers vested in the
26 Council by Section 1(f) of Article VI of the Constitution of
27 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
