WHEREAS, the Child Care Food Program of the State of Arizona has funded breakfast, lunch and snacks of the Tohono O'odham Early Childhood Head Start Program by means of an Intergovernmental Food Service Agreement between the Tohono O'odham Nation and the State of Arizona; and

WHEREAS, the Tohono O'odham Early Childhood Head Start Program has recommended renewal of said agreement, effective October 1,1988 and support the Early Childhood Head Start Program continuance of the Child Care Food Program.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation that it does hereby approve the renewal of the application implementing the Child Care Food Program from October 1, 1988 through September 30, 1989.

BE IT FURTHER RESOLVED that the Chairman, Vice Chairman and Treasurer of the Tohono O'odham Nation are authorized to execute the Intergovernmental Food Service Agreement, or any amendments thereto.

The foregoing resolution was passed by the Tohono O'odham Council on the 26th. day of September, 1988 at a meeting at which a quorum was present with a vote of 1,640.0 for; -0- against; -0- not voting; and 06 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
