

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Water Resources Committee Budget)

RES. NO. 272-88

1 WHEREAS, the Legislative Council did allocate Water Trust funds
2 for the Water Commissioners for the purpose of paying
3 costs for work performed on water activities for the
4 Nation; and

5 WHEREAS, the Water Commission had been redesignated as the Water
6 Resource Committee and are delegated the
7 responsibilities for water activities of the Nation; and

8 WHEREAS, the Legislative Council did request that the Water
9 Resources Committee develop a budget and submit to the
10 Council for review and action; and

11 WHEREAS, the Water Resources Committee have developed and
12 approved a budget in the sum of \$55,508.72 effective Oct
13 1, 1988 to September 30, 1989; and

14 WHEREAS, the Budget and Finance Committee has reviewed and
15 approved the budget as submitted by the Water Resources
16 Committee.

17 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does
18 hereby approve the Water Resources Committee budget in
19 the amount of \$55,508.72, effective Oct 1, 1988 to
20 September 30, 1989 and that these funds be allocated
21 from the Water Trust funds as previously authorized for
22 this Committee.

23 The foregoing resolution was passed by the Tohono O'odham Council
24 on the 26th. day of September, 1988 at a meeting at which a
25 quorum was present with a vote of 750.5 for; 430.5 against; 459.0
26 not voting; and 06 absent, pursuant to the powers vested in the
27 Council by Section 1 (d) of Article VI of the Constitution of
28 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
29 on January 18, 1986, and approved by the Acting Deputy Assistant
30 Secretary - Indian Affairs (Operations) on March 6, 1986,
31 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
32 984).
