WHEREAS,	the Legislative Council did hear a request by the Public
	Water Supply Supervision Program (PWSSP) to change the
	title of the program to the Public Water Systems Program
	(PWSP); and

- WHEREAS, the Legislative Council on September 27, 1988 reviewed the proposed Public Water Systems Program budget in the amount of \$40,585.00; and
- whereas, the appropriate Committees did review the proposed budget and have referred it to the Legislative Council for their immediate action; and
- WHEREAS, the Water Resources Committee has recommended that the decision to transfer the Nation's operation of the public water systems which are not currently under PTUA to the Utility be delayed until March 31, 1989 and that the collection of water samples and payment for test analyses by PWSP will be extended until March 31, 1989; and
- WHEREAS, the intent of the proposal is to fulfill the Tohono
  O'odham Nation objective to comply with the Safe
  Drinking Water Act and to assume the regulatory and
  enforcement role presently administered by EPA.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative

  Council that it hereby approves the Public Water Systems

  Program budget in the amount of \$40,585.00 effective

  October 1, 1988 to September 30, 1989.
- BE IT FURTHER RESOLVED that the funds to cover the budget come from the Tohono O'odham Water Trust Fund.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Water Resources Committee is hereby directed to present a report on the take-over of the public water systems.
