

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'Odham Nation's Economic Development Fund)

RES. NO. 274-88

1 WHEREAS, the Tohono O'Odham Legislative Council is in the process  
2 of adopting FY '89 budgets for the Tohono O'Odham  
3 Nation; and

4 WHEREAS, \$250,000.00 was appropriated in FY '88 for the purpose  
5 of providing matching funds in the establishment of a  
6 Revolving Loan Program under the Credit & Finance  
7 Office; and

8 WHEREAS, the establishment of a Revolving Loan Program was a  
9 lengthy process and has yet to be finalized; and

10 WHEREAS, the Credit & Finance Committee's Plan of Operation is  
11 presently pending Legislative Committee review for  
12 adoption; and

13 WHEREAS, the Credit & Finance Program is fully established to  
14 provide technical assistance for businesses.

15 NOW, THEREFORE, BE IT RESOLVED that the \$250,000.00 matching  
16 funds appropriated in FY '88 Revolving Loan Program be  
17 carried forward into the FY '89 Tohono O'Odham Nation  
18 Budget.

19 BE IT FURTHER RESOLVED that the adopted FY '89 Budget of the  
20 Tohono O'Odham Nation is hereby amended to include the  
21 amount of \$250,000.00 herein authorized.

22 The foregoing Resolution was passed by the Tohono O'odham Council  
23 on the 27th day of September, 1988 at a meeting at which a  
24 quorum was present with a vote of 1,000.5 for; 258.5 against;  
25 381.0 not voting; and 07 absent, pursuant to the powers vested  
26 in the Council by Section 1(d) of Article VI of the  
27 Constitution of the Tohono O'odham Nation, adopted by the Tohono  
28 O'odham Nation on January 18, 1986, and approved by the Acting  
29 Deputy Assistant Secretary - Indian Affairs (Operations) on March  
30 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
31 Stat. 984).
