

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of the Resignation of Legislative Council
Committee Members)

2 WHEREAS, the Legislative Council did appoint Fernando Joaquin,
3 Legislative Council Representative, to the Commerce
4 Committee by Resolution No. 199-87 and did appoint Percy
5 Lopez, Legislative Council Representative, to the Rules
6 Committee by Resolution No. 216-87; and

7 WHEREAS, the Legislative Council did by Legislative Order No.
8 105-88 reaffirm the Legislative Rules which states that:
9 "A Legislative Representative may serve on three, but no
10 more than three, Legislative Committees;" and

11 WHEREAS, the Rules committee of the Legislative Council has
12 presented and is recommending the acceptance of the
13 resignation of Fernando Joaquin from the Commerce
14 Committee and Percy Lopez from the Rules Committee.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
16 Legislative Council does hereby accept the resignations
17 of Fernando Joaquin from the Commerce Committee and
18 Percy Lopez from the Rules Committee.

19 The foregoing Resolution was passed by the Tohono O'odham Council
20 on the 27th. day of September, 1988 at a meeting at which a
21 quorum was present with a vote of 1,514.0 for; -0- against;
22 126.0 not voting; and 06 absent, pursuant to the powers vested
23 in the Council by Section 1 (a) & (b) of Article VI of the
24 Constitution of the Tohono O'odham Nation, adopted by the Tohono
25 O'odham Nation on January 18, 1986, and approved by the Acting
26 Deputy Assistant Secretary - Indian Affairs (Operations) on March
27 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).
