WHEREAS, a veto on Resolution No. 264-88 is anticipated; and WHEREAS, immediate action should be considered in the event of a veto.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends its agenda for September 27, 1988, to add the anticipated veto of Resolution No. 264-88, "Adoption of Tohono O'odham Nation's Fy '89 Budget including Projected Revenues and Committee Recommendations."

The foregoing ORDER was passed by the Tohono O'odham Council on the 27th. day of September, 1988 at a meeting at which a quorum was present with a vote of 1,174.5 for; 143.0 against; 322.5 not voting; and 06 absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
