WHEREAS, the Legislative Council would like to be prepared to address the anticipated veto of Resolution No. 264-88.

whereas, it was suggested to meet on September 29, 1988 to address the anticipated veto of Resolution No. 264-88.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby reconvenes on Thursday, September 29, 1988, to address the anticipated veto of Resolution No. 264-88, "Adoption of Tohono O'odham Nation's Fy '89 Budget including Projected Revenues and Committee Recommendations."

The foregoing ORDER was PASSED by the Tohono O'odham Council on the 27th. day of September, 1988 at a meeting at which a quorum was present with a vote of 1,114.5 for; 116.5 against; 281.0 not voting; and 128.0 (08) absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
