NO. 281-88 1 WHEREAS, the Legislative Council did by Resolution No. 264-88 2 Adopt the Tohono O'Odham Nation's FY ' 89 Budgets 3 including Projected Revenues and Committee 4 Recommendations; and 5 WHEREAS, upon presentation of Resolution No. 264-88 to the 6 Chairman of the Tohono O'Odham Nation he did disapprove 7 thereof and returning it to the Council with his 8 objections in accordance with the provisions of Article 9 VII, Section 5 of the Constitution of the Tohono O'Odham 10 Nation; and 11 WHEREAS, the Legislative Council has reviewed the Chairman's 12 objections and after consideration again voted to pass 13 Resolution No. 264-88 14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham 15 Legislative Council does hereby override the Chairman's 16 veto of Resolution No. 264-88, by a vote of two-17 thirds (2/3) of the votes cast 752.0. 18 The foregoing resolution was presented to the Tohono O'Odham 19 Legislative Council on the 29th. day of September, 1988, at a meeting at which a quorum was present and by a vote of 764.0 for; 20 255.5 not voting; and 257.0 absent, DID OVERRIDE veto of Resolution No.264-88 pursuant to the 363.0 against; the Chairman's of Resolution No.264-88 pursuant to the 21 powers vested in the Council by Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono 22 O'Odham Nation on January 18, 1986 and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 23 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 24 25 TOHONO O'ODHAM LEGISLATIVE COUNCIL 26 27 Harriet Toro, Legislative Chairperson 28 29th day of September, 1988. 29
