(Override Veto of Resolution No. 264-88 "Adoption
of the Tohono O'Odham Nation's FY '89 Budgets
including Projected Revenues and Committee Recommendations)

2 WHEREAS, the Legislative Council did by Resolution No. 264-88
3 Adopt the Tohono O'Odham Nation's FY '89 Budgets
4 including Projected Revenues and Committee
5 Recommendations; and

6 WHEREAS, upon presentation of Resolution No. 264-88 to the
7 Chairman of the Tohono O'Odham Nation he did disapprove
8 thereof and returning it to the Council with his
9 objections in accordance with the provisions of Article
10 VII, Section 5 of the Constitution of the Tohono O'Odham
11 Nation; and

12 WHEREAS, the Legislative Council has reviewed the Chairman's
13 objections and after consideration again voted to pass
14 Resolution No. 264-88

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
16 Legislative Council does hereby override the Chairman's
17 veto of Resolution No. 264-88, by a vote of two-
18 thirds (2/3) of the votes cast 752.0.


19 The foregoing resolution was presented to the Tohono O'Odham
20 Legislative Council on the 29th day of September, 1988, at a
21 meeting at which a quorum was present and by a vote of 764.0 for;
22 363.0 against; 255.5 not voting; and 257.0 absent, DID OVERRIDE
23 the Chairman's veto of Resolution No. 264-88 pursuant to the
24 powers vested in the Council by Section 5 of Article VII of the
25 Constitution of the Tohono O'Odham Nation, adopted by the Tohono
26 O'Odham Nation on January 18, 1986 and approved by the Acting
27 Deputy Assistant Secretary - Indian Affairs (Operations) on March
28 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
29 Stat. 984).


