

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(In support of Tohono O'Odham Judiciary's Application
for ANA Funds)

RES. NO. 283-88

1 WHEREAS, the Administration for Native American programs has
2 published a notice of intent to fund American Indian
3 Tribes interested in applying for funds in accordance
4 with ANA funding priorities; and

5 WHEREAS, the ANA funding priority goals of Governance and Social
6 Development are areas which the Tohono O'Odham Judiciary
7 is interested in developing programs and services for
8 member clients; and

9 WHEREAS, the Tohono O'Odham Judiciary has prepared an application
10 in accordance with the instructions issued by ANA; and

11 WHEREAS, a requirement is a resolution authorizing the
12 application to be submitted; and

13 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
14 application and the objectives of the proposed project
15 and supports the same.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
17 Council that it does support the Tohono O'Odham
18 Judiciary's application to seek funding from the ANA for
19 the proposed projects and services for client members,
20 and the Chairman, Vice-Chairman or Treasurer are
21 directed and authorized to negotiate, enter into and
22 execute any and all documents, including any
23 amendments, necessary to implement the intent and
24 purposes of this resolution.

26 The foregoing Resolution was passed by the Tohono O'odham Council
27 on the 11th. day of October, 1988 at a meeting at which a quorum
28 was present with a vote of 1,052.0 for; 63.0 against; 525.0
29 not voting; and 02 absent, pursuant to the powers vested in the
30 Council by Section 1 (f) of Article VI of the Constitution of
31 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
32 on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
