WHEREAS, the Council has been advised that compliance by the 8 Court with the Court's order and writ of mandamus will 9 result in a malapportionment of the votes since it will 10 cause certain representatives on the Council to include 11 in their votes the count of resident members who are 12 registered to vote elsewhere; will result in the 13 destruction of custom and tradition which encourage 14 members to register and vote in the districts of their 15 forebears: and will result in an impermissible 16 interference by the judicial branch in the legislative 17 prerogative of this Council. 18

NOW, THEREFORE, it is hereby ordered that the Council does hereby 19 appeal the Court's opinion, order and writ of mandamus 20entered in Garcia v. Tohono O'Odham Council, and that 21the Chairperson of the Council and the attorneys and 22other appropriate officers of the Nation are hereby 23authorized and directed to file and prosecute all proper $\mathbf{24}$ appeals and stays thereof. 25

The foregoing Legislative Orderwas passed by the Tohono O'odham Council on the <u>11th.</u> day of <u>October</u>, <u>1988</u> at a meeting at which a quorum was present with a vote of <u>1,113.5</u> for; <u>405.0</u> against; <u>121.5</u> not voting; and <u>02</u> absent, pursuant to the powers vested in the Council by Section <u>7</u> of Article X of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. <u>984</u>).
