

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Disease Prevention and Control Services Branch
TOHD Proposal to the Arizona Department of Health Services)

RES. NO. 285-88

1 WHEREAS, the Tohono O'Odham Legislative Council is aware of the
2 health threat of the disease AIDS; and

3 WHEREAS, the Tohono O'Odham Health Board of the Tohono O'Odham
4 Nation has recognized that AIDS, as a communicable and
5 incurable disease, poses a public health threat for
6 members and/or residents of the Tohono O'Odham Nation;
7 and

8 WHEREAS, the Tohono O'Odham Health Board has mandated that the
9 Health Department develop an AIDS Prevention Program
10 which will be a community oriented education project;
11 and

12 WHEREAS, the Disease Prevention and Control Services Branch of
13 the Tohono o'Odham Health Department received and
14 responded to a request for proposal submission for the
15 Development of Effective AIDS Teaching Methods and
16 Materials from the Arizona Department of health Services
17 in the amount of \$22,934.00 for a six month duration.

18 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
19 Council that it does hereby approve the proposal from
20 the Development of Effective AIDS Teaching Methods and
21 Materials from the Arizona Department of Health Services
22 in the amount of \$22,934.00 for a six month duration.

23 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
24 that the Chairman, Vice-Chairman or Treasurer of the
25 Tohono O'Odham Nation are hereby authorized to negotiate
26 and execute this contract and any amendments thereto for
27 the duration of the contract, provided however, that any
28 amendments affecting the funding or funding levels of
29 this contract shall be submitted for further prior
30 approval by this Council.

32 The foregoing Resolution was passed by the Tohono O'odham Council
on the 12th. day of September, 1988 at a meeting at which a
quorum was present with a vote of 1,640.0 for; -0- against; -0-
not voting; and 02 absent, pursuant to the powers vested in the

1 Council by Section 1 (f) of Article VI of the Constitution of the
2 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
3 January 18, 1986, and approved by the Acting Deputy Assistant
4 Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
