

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Food Distribution & Family Nutrition Services)

RES. NO. 286-88

1 WHEREAS, the Tohono O'Odham Nation has operated successfully a
2 program whereby the diet and nutritional needs of
3 eligible Tohono O'Odham people have been served by
4 supplementing other federal social service programs; and

5 WHEREAS, the funding for the Tohono O'Odham Food
6 Distribution/Family Nutrition Services has been provided
7 through the United States Department of Agriculture; and

8 WHEREAS, the continued operation of the Food Distribution Program
9 is essential to provide basic diet and nutrition for
10 eligible clients.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
12 Council that it hereby approves the application for
13 continued funding of the Tohono O'Odham Food
14 Distribution/Family Nutrition Services from the United
15 States Department of Agriculture.

16 BE IT FURTHER RESOLVED that the duration of this grant will be
17 from October 01, 1988 through September 30, 1989 unless
18 extended by mutual agreement of both contracting
19 parties.

20 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
21 that the Tohono O'Odham Nation will not fund or operate
22 the program in the interim while negotiations are still
23 being conducted and no executed grant has been awarded
24 by the U.S. Department of Agriculture.

25 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
26 that the Chairman, Vice-Chairman or Treasurer of the
27 Tohono O'Odham Nation are hereby authorized to negotiate
28 and execute this grant and any amendments thereto for
29 the duration of the grant, provided however, that any
30 amendments affecting the funding or funding levels of
31 this grant shall be submitted for further prior
32 approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 12th day of October, 1988 at a meeting at which a quorum was present with a vote of 1,640.0 for; -0- against; -0- not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
