

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 1989 Budget for the San Lucy District  
in the amount of \$650,329.00)

RES. NO. 287-88

1 WHEREAS, on October 20, 1986, Public Law 99-503 was enacted into  
2 law, authorizing payment to the Tohono O'Odham Nation  
3 the sum of Thirty Million Dollars (\$30,000,000.00) plus  
4 interest, Ten Million Dollars (\$10,000,000.00) plus  
5 interest in FY 1988, Ten Million Dollars  
6 (\$10,000,000.00) plus interest in FY 1989, Ten Million  
7 Dollars (\$10,000,000.00) plus interest in FY 1990; and

8 WHEREAS, Public Law 99-503 provides that the authorized Governing  
9 Body of the Nation may spend the principal and interest  
10 and dividends accruing on such sums on behalf of the San  
11 Lucy District for land and water rights acquisition,  
12 economic and community development, and relocation  
13 costs; and

14 WHEREAS, on April 21, 1988 the Tohono O'Odham Nation received the  
15 first installment payment of Ten Million Dollars  
16 (\$10,000,000.00) plus interest which is being maintained  
17 at the Nation's financial institution, namely the First  
18 Interstate Bank, in a separate bank account referred to  
19 as San Lucy District - P.L. 99-503 funds; and

20 WHEREAS, the San Lucy District in FY 1988 has begun an earnest  
21 effort to implement said requirements of P. L. 99-503;  
22 and

23 WHEREAS, the San Lucy District Council desires to continue its  
24 efforts in FY 1989 and has developed a budget with line  
25 item justifications thereof is attached hereto and made  
26 a part hereof; and

27 WHEREAS, the San Lucy District's budget in the amount of Six  
28 Hundred Fifty Thousand Three Hundred Twenty-Nine Dollars  
29 (\$650,329.00) has been prepared pursuant to the  
30 Legislative Council Resolution #450-87, segregating  
31 projected expenditures per line item which are properly  
32 attributed to the District's purely governmental  
operations from those authorized under P. L. 99-503; and

1 WHEREAS, funds are available to the San Lucy District through the  
2 All Districts I.I.M. Account; and

3 WHEREAS, the Budget and Finance Committee of the Tohono O'Odham  
4 Legislative Council did review the FY 1989 Budget of the  
5 San Lucy District on October 06, 1988 and recommends  
6 approval.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
8 Council that the FY 1989 Budget for the San Lucy  
9 District is hereby approved commencing October 01, 1988  
10 to September 30, 1989 in the amount of \$650,329.00 .

11 BE IT FURTHER RESOLVED that those expenditures which are properly  
12 attributed to the District's purely governmental  
13 operations not to exceed Thirty Thousand Ninety-Five  
14 Dollars (\$30,095.00) shall be reimbursed to the San Lucy  
15 District's P. L. 99-503 account at the Nation's  
16 Accounting Office, First Interstate Bank, through the  
17 San Lucy District's share of the All District's I.I.M.  
18 Account.

20 The foregoing Resolution was passed by the Tohono O'odham Council  
21 on the 13th day of October, 1988 at a meeting at which a quorum  
22 was present with a vote of 1,524.0 for; 116.0 against; -0- not  
23 voting; and 02 absent, pursuant to the powers vested in the  
24 Council by Section 1 (d) of Article VI of the Constitution of  
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
