

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Renewal of Title II Grant "Teen Parent Day Care Program")

RES. NO. 28-88

1 WHEREAS, the Tohono O'Odham Human Services Department has the
2 primary responsibility to provide for the care,
3 treatment and welfare of children found to be in need of
4 such care; and

5 WHEREAS, Title II of the Indian Child Welfare Act of 1978
6 provides funds for development of child welfare programs
7 under specified terms and conditions; and

8 WHEREAS, the incidence of teenage parents on the Tohono O'Odham
9 Reservation is high and school based day care and after
10 school care is not available to this group; and

11 WHEREAS, the Tohono O'Odham Human Services Department is capable
12 of developing and administering day care program that
13 will focus on keeping teenage parents in school and
14 provide educational component to increase parent skills;
15 and

16 WHEREAS, the need for such a program is well documented and
17 Tohono O'Odham Human Services is capable of implementing
18 the programs.

19 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
20 Council that it does hereby approve the renewal
21 application of Tohono O'Odham Human Services a three
22 year Title II grant to develop and implement a Teen
23 Parent school based Day Care and decrease the incidents
24 of child abuse and neglect and decrease school dropouts
25 of teen parents through a school based day care program
26 with educational and social service component.

27 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or
28 Treasurer of the Tohono O'Odham Nation are hereby
29 authorized to negotiate and execute this Grant and any
30 amendments thereto for the duration of this Grant,
31 provided however, that any amendments affecting the
32 funding or funding levels of this contract shall be
submitted for further prior approval by this Council.


The foregoing resolution was passed by the Tohono O'odham Council on the 3rd. day of February, 1988, at a meeting at which a quorum was present with a vote of 1,434.5 for; 42.5 against; 163.0 not voting; and -0- absent; pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




