

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Supporting Strong NCAI Housing Position and Paper)

RES. NO. 296-88

1 WHEREAS, the National Indian Housing Council has prepared a  
2 Position Paper on Indian Housing needs, utilizing the  
3 1987 Indian Housing Survey which was conducted by the  
4 Bureau of Indian Affairs and which further indicated  
5 that there was an increase of housing needs in the  
6 amount of 30,000 new/or substantially rehabilitated  
7 homes as compared to the 1970 survey; and

8 WHEREAS, both surveys demonstrates the serious failing of the  
9 federal government to meet the shortfall of Indian  
10 Housing needs and this is further supported by the  
11 Congressional Appropriations, which showed that the  
12 1980 appropriation went, in 1980, from 848 million to  
13 148 million in 1988, a decrease of \$700,000,000; and

14 WHEREAS, the Tohono O'Odham Nation and its Housing Committee  
15 supports the National Indian Housing Council in its  
16 Demonstration Position Paper which reflects housing  
17 needs on a national level in Indian country.

18 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation  
19 urges the National Congress of American Indians  
20 organization to lobby Congress for additional annual  
21 appropriation of funding to address and meet the  
22 American Indian Housing needs and also to urge Congress  
23 to develop new ways for Indian families to obtain  
24 financing for new construction

26 The foregoing Resolution was passed by the Tohono O'odham Council  
27 on the 19th. day of October, 1988 at a meeting at which a quorum  
28 was present with a vote of 1,640.0 for; -0- against; -0- not  
29 voting; and -0- absent, pursuant to the powers vested in the  
30 Council by Section 1 (j) of Article VI of the Constitution of  
31 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
32 on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
