15	(1) Treaties with the U.S. Government
16	(2) Enrollment in a federally recognized tribe
17	(3) Been included in the 1960 BIA census
18	(4) Having sufficient evidence of Indian language, history, foods, technology and religion.
19 20	(5) Recognized by National Tribal Indian Organizations to be a member of the root race or aborigine.
21	(6) Having a claim settled by or before, the U.S. Claims Commission
22	(7) Be an offspring of sufficient blood quantum
23	recognized by the tribe, with proof of parents qualification under any four (4) of the above.
