

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY '88 Budget for the San Lucy District  
in the amount of \$334,904.02)

RES. NO. 29-88

1  
2 WHEREAS, the Legislative Council did by Resolution No. 399-87  
3 approve the FY '88 Budget for the San Lucy District and  
4 did authorize a loan guarantee or loan, not to exceed  
5 \$1,892,855.00 to fund such budget, to be repaid from  
6 Public Law 99-503 settlement funds; and

7 WHEREAS, the Nation did advance to the San Lucy District the sum  
8 of \$473,213.75 pursuant to Resolution No. 399-87 which  
9 amounts to one-fourth (1/4) of the District Budget for  
10 FY '88 (\$1,892,855.00); and

11 WHEREAS, the Legislative Council did by Resolution No. 450-87  
12 authorize the expenditures by the San Lucy District  
13 Council of a sum not to exceed \$473,213.75 for FY '88;  
14 provided that the authorization to spend funds is  
15 conditioned upon the District submitting a new budget  
16 excluding Equipment and Vehicle Purchase and Consultant  
17 Services for approval by the Budget and Finance  
18 Committee and Council within thirty (30) days of  
19 enactment of Resolution No. 450-87; and

20 WHEREAS, the Legislative Council did by Resolution No. 452-87  
21 order the return to the Nation within five (5) working  
22 days of the effective date of the Resolution, all  
23 unexpended funds previously advanced to the District  
24 pursuant to Resolution No. 399-87, which funds shall be  
25 expended for the benefit of the San Lucy District  
26 pursuant to authorization contained in Resolution No.  
27 450-87; and

28 WHEREAS, the San Lucy District did on January 11, 1988 return to  
29 the Nation the sum of \$334,924.18 and did provide to  
30 Daniel Lansberry, Comptroller, a report of the list of  
31 expenditures for review and certification; and

32 WHEREAS, the San Lucy District did on January 25, 1988 submit for  
review and recommendation, a new budget and other

1 supporting documentation to the Budget and Finance  
2 Committee pursuant to Resolution No. 450-87; and  
3 WHEREAS, the Budget and Finance Committee did review the new  
4 budget of the San Lucy District on February 2, 1988 and  
5 recommends approval.

6 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
7 Council that the FY '88 Budget for the San Lucy District  
8 is hereby approved commencing January 10, 1988 to  
9 September 30, 1988 in the amount of \$334,904.02.

10 BE IT FURTHER RESOLVED that the San Lucy District Council shall  
11 hereby agree to reimburse to the Nation the sum of  
12 \$473,213.75 advanced to the District, plus eight percent  
13 (8%) interest thereon from the settlement funds made  
14 available pursuant to Public Law 99-503; and that those  
15 expenditures which do not meet the requirements of the  
16 Act (not to exceed \$10,361.23 plus eight percent (8%)  
17 interest) will be reimbursed to the Nation through the  
18 San Lucy District's share of the All Districts I.I.M.  
19 Account.

21 The foregoing resolution was passed by the Tohono O'odham  
22 Council on the 4th day of February, 1988 at a meeting at which a  
23 quorum was present with a vote of 1,512.5 for; -0- against; 127.5  
24 not voting; and 02 absent; pursuant to the powers vested in the  
25 Council by Section 1 d (3) of Article VI of the Constitution of  
26 the Tohono O'odham Nation on January 18, 1986, and approved by  
27 the Acting Deputy Assistant Secretary - Indian Affairs  
28 (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
29 of June 18, 1934 (48 Stat. 984).
