WHEREAS, the Judiciary Committee presented to the Legislative
Council Chapter I entitled "Tohono O'Odham Judiciary and
Chapter 2 entitled "Judicial Officers and Personnel" for
review and enactment; and

WHEREAS, the Legislative Council raised questions to the Judiciary Committee regarding Section 2-101 Judges Pro Tempore, because it seems to be in conflict with the Constitution under Article VIII Section 3; and

WHEREAS, the Legislative Council felt that the section in question should be reviewed again by the Judiciary Committee to clear up any possible conflicts with our Constitution.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that Chapter 2 entitled "Judicial Officers and Personnel Section 2-101 Judges Pro Tempore is hereby referred back to the Judiciary Committee for further clarification.

The foregoing Legislative Order was passed by the Tohono O'odham Council on the 19th. day of October, 1988 at a meeting at which a quorum was present with a vote of 848.5 for; 570.5 against; 221.0 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
