26 the above named applicants are eligible for enrollment
27 as members of the Tohono O'Odham Nation under Section
28 1(a) or (b) of Article II of the Constitution of the
29 Tohono O'Odham Nation, and that their applications are
30 approved, as herein above indicated.

31 BE IT FURTHER RESOLVED that the Chairman and other appropriate
32 officers of the Tohono O'Odham Nation reduce this final
determination in writing regarding each of the foregoing

1 applications for enrollment in accordance with Section 3
2 (c) of Article III of the Enrollment Ordinance; give
3 notice of this Council's determination in accordance
4 with Section 4 of Article III of the Enrollment
5 Ordinance; and place the names of each applicant upon
6 the membership roll of the Tohono O'Odham Nation in
7 accordance with Article V of the Enrollment Ordinance.

8 The foregoing Resolution was passed by the Tohono O'Odham Council
9 on the 7th. day of November, 1988 at a meeting at which a quorum
10 was present with a vote of 1,402.0 for; -0- against; 238.0 not
11 voting; and 02 absent, pursuant to the powers vested in the
12 Council by Section 1 of Article II and of Section 1 (h) of
13 Article VI of the Constitution of the Tohono O'Odham Nation,
14 adopted by the Tohono O'Odham Nation on January 18, 1986 and
15 approved by the Acting Deputy Assistant Secretary - Indian
16 Affairs (Operations) on March 6, 1986 pursuant to Section 16 of
17 the Act of June 18, 1934 (48 Stat. 984).
